

SCANSOURCE GIVE US YOUR INSIGHT SWEEPSTAKES

OFFICIAL RULES

The ScanSource Give us your Insight Sweepstakes (the “Sweepstakes”) is sponsored by ScanSource, Inc. (“ScanSource” or “Sponsor”) and is open only to “Insight Sales Reps.” who are defined as individuals who are: (1) full time employees of Insight Enterprises, Inc. (“Insight”) with the title of Sales Representatives (2) 21 years of age or older; and (3) legal residents of the 50 United States and the District of Columbia. Direct Marketers (“DMARs”), “e-tailers,” other Distributors, Manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Sweepstakes.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT ENHANCE YOUR CHANCE OF WINNING. VOID IN PUERTO RICO, U.S. VIRGIN ISLANDS, U.S. TERRITORIES AND POSSESSIONS, AND WHERE PROHIBITED OR RESTRICTED BY LAW.

1. SWEEPSTAKES PERIOD; VALID SUPPLIER.

(A) Sweepstakes Period. The Sweepstakes begins April 1, 2021 and ends September 30, 2021 at 11:59:59 p.m. (Eastern Time) (the “Sweepstakes Period”). For purposes of the Sweepstakes, a “day” begins at 12:00:01 a.m. (Eastern Time) and ends at 11:59:59 p.m. (Eastern Time). Sponsor’s clock is the official time-keeping device for this Sweepstakes.

(B) Valid Supplier. For purposes of these Official Rules, “Valid Supplier” is defined as Datalogic.

2. HOW TO ENTER. Insight Sales Reps may enter and receive Sweepstakes entries the following ways:

(A) Deal Registration Entries.

(1) Deal Registrations. For purposes of these Official Rules:

(a) a “Deal Registration” is defined as a *potential* sale of Valid Supplier products (purchased from ScanSource and sold to a third party) that has been registered by an Insight Sales Rep through the submission of a completed Deal Registration Form (at www._____) during the Sweepstakes Period;

(b) a “Shipped Deal Registration” is defined as any Deal Registration submitted by an Insight Sales Rep that results in the actual sale of Valid Supplier products to a third party that is scheduled for shipment and actually shipped by ScanSource during the Sweepstakes Period.

(2) Deal Registration Entries. An Insight Sales Rep will receive: (a) one (1) Sweepstakes entry for a Deal Registration in the amount of \$1 - 9,999; (b) two (2) Sweepstakes entries for a Deal Registration in the amount of \$10,000 – \$24,999; (c) three (3) Sweepstakes entries for a Deal Registration in the amount of \$25,000 - \$49,999 and (d) five (5) Sweepstakes entries for a Deal Registration in the amount of \$50,000 or more.

(3) Shipped Deal Registration Entries. An Insight Sales Rep will receive ten (10) Sweepstakes entries for each Shipped Deal Registration (of any amount) that is scheduled for shipment and actually shipped by ScanSource during the Sweepstakes Period.

(4) Services quote Entries. An Insight Sales Rep will receive one (1) Sweepstakes entry for every Valid Supplier services quote request submitted during the Sweepstakes Period.

(C) Mail-in Entries. An Insight Sales Rep may also receive one (1) Sweepstakes entry without completing a service quote request or a Deal Registration (and without purchasing/selling Valid Supplier

products) by hand-printing the Insight Sales Rep's name, address, city, state, zip, email, and phone number, and the words "ScanSource Give us your Insight Sweepstakes Entry" on a 3"x 5" card, and mailing the card in a stamped envelope to: ScanSource Give us your Insight Sweepstakes Entries, ScanSource, Inc., 6 Logue Court, Greenville, SC 29615 (USA). In order to be entered, a mail-in entry must be postmarked by September 30, 2021, and be received by Sponsor on or before October 8, 2021. An Insight Sales Rep will receive one (1) Sweepstakes entry for timely submitting a mail-in card entry. *Only one (1) mail-in Sweepstakes entry per stamped envelope will be accepted.*

(D) **General Participation Matters.** Each service quote request and each Deal Registration must be original and unique; no duplicates or copies of service quote requests or Deal Registrations will be accepted. No copies or mechanical reproductions of mail-in Sweepstakes entries will be accepted. Any illegible, unintelligible, incomplete, postage-due, or garbled entries are not permitted and will be disqualified and any entries not in conformance with these Official Rules will be disqualified. Neither Sponsor nor any of its employees, representatives or agencies, is responsible for lost, postage-due, late, damaged, delayed, destroyed, misdirected, incomplete, or illegible entries. Once submitted, entries become the exclusive property of Sponsor and will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor. By participating, participants give their express permission to be contacted by Sponsor by mail, email, facsimile and telephone. Any personal information collected in connection with this Sweepstakes will be used in accordance with Sponsor's privacy policy. By participating, participants agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects. 3. ELIGIBILITY. The Sweepstakes is open only to "Insight Sales Reps," who are defined as individuals who are: (a) full time employees of Insight with the title of Sales Representative; (b) 21 years of age or older; and (c) legal residents of the 50 United States and the District of Columbia. Direct Marketers ("DMARs"), "e-tailers," Distributors, Manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Sweepstakes. Officers, directors, and employees of Sponsor and its parents, subsidiaries, and other affiliated companies, agents, and advertising and promotional agencies, and their immediate family members (defined as parents, spouse, children, siblings, grandparents) and those with whom they are domiciled, are NOT eligible to enter or win.

4. SELECTION OF WINNERS/ODDS OF WINNING PRIZE. Sponsor will award one (1) Sweepstakes Grand Prize, one (1) Sweepstakes First Prize, and one (1) Sweepstakes Second Prize winner in a random drawing on or about October 9, 2021 in Greenville, South Carolina. Odds of winning depend on the number of eligible entries received. Limit one (1) Sweepstakes prize per person/per Insight Sales Rep. Potential Sweepstakes winners will be notified by email, telephone, mail or facsimile. Unclaimed prizes may not be awarded.

Each potential Sweepstakes winner must comply with all of the terms and conditions of these Official Rules; winning prize is contingent upon fulfilling all requirements. Potential prize winners may be required to sign and return an Affidavit of Eligibility and Release (an "Affidavit") within fourteen (14) days of notification/verification in order to receive prize. In the event: (a) a potential winner cannot be reached for whatever reason after a reasonable effort has been exerted based on the information submitted, (b) of noncompliance with the above or within any of the aforesaid time periods, (c) a potential prize winner is found to be ineligible to enter the Sweepstakes or receive the prize, (d) a potential winner cannot or does not comply with the Official Rules, (e) a potential winner's prize notification or Affidavit is returned as undeliverable for whatever reason, or (f) a potential winner fails to fulfill the Affidavit-related obligations, the potential winner may be disqualified from receiving the prize and/or disqualified from the Sweepstakes. In the event that a potential winner is disqualified from receiving Sweepstakes prize, Sponsor may, at its

sole discretion, award the prize to an alternate potential winner by a random drawing from among the other eligible entries received.

In the event of a dispute as to the identity of a potential winner based on an email address, the winning entry will be deemed to be the authorized account holder of the email address submitted at time of entry. For purposes hereof, an “authorized account holder” is the natural person who is assigned to an email address by an Internet access provider, on-line service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

5. PRIZES. Sponsor will award one (1) Sweepstakes Grand Prize consisting of winner’s choice of either (a) a Herman Miller Chair (ARV: \$795) or (b) a Dyson V10 Vacuum (ARV: \$249), one (1) Sweepstakes First Prize consisting of winner’s choice of either (a) a Micro Power Desk Riser (ARV: \$269) or (b) a set of Apple AirPods Pro (ARV: \$249) and one (1) Sweepstakes Second Prize consisting of winner’s choice of either (a) a Vertou Next (ARV: \$159) or (b) Ugg Ascot slippers (ARV: \$110)

Prizes are non-transferable. Unless otherwise specifically provided for herein, all taxes or expenses, including, without limitation, expenses associated with the prizes (not specified herein as part of prize), sales tax, luxury tax, and any other costs incurred in claiming or using any of the prizes, are the sole responsibility of the prize winner. No prize substitution or cash equivalent of prize, except at Sponsor’s sole discretion, and then only for a prize of equal or greater value. Any difference between the actual value of any prize and the approximate retail value set forth in these Official Rules may not be claimed and will not be awarded.

6. GENERAL CONDITIONS.

(A) This Sweepstakes is subject to all federal, state and local laws and regulations. The laws of the United States of America shall be deemed to govern the Sweepstakes.

(B) Acceptance of prize shall constitute and signify winner’s agreement and consent that Sponsor may use winner’s name, address (city and state only), biographical data, voice, likeness, image, statements, and prize information, in any and all media now existing or hereafter devised for illustration, promotion, art, editorial, advertising, trade or any other purpose whatsoever, in perpetuity, without attribution, notification, compensation or consents (except where prohibited by law), and winner hereby releases Sponsor from any liability with respect thereto.

(C) Participant, by participating, releases and agrees to hold harmless Sponsor and their parents, affiliates, subsidiary companies, advertising and promotion agencies, and agents and their respective directors, officers, employees, representatives and agents from any and all liability for any accident, loss, tax liability, injury, death or damage of any kind, arising from participant’s participation in this Sweepstakes or in any Sweepstakes related activity, or resulting from acceptance, possession, use or misuse of any prize, or while traveling to and/or from a location as part of or to obtain or use a prize. Without limiting the foregoing, all prizes are provided “as is” without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose, or non-infringement. (Any and all guarantees and warranties on merchandise prizes are subject to the manufacturer’s terms and conditions, and winners agree to solely look to such manufacturers for any such warranty or guarantee claim.)

(D) Sponsor and its parents, affiliates, subsidiary companies, advertising and promotion agencies, and agents and contest administrators and their respective directors, officers, employees, representatives and agents are not responsible for any typographical or other error in the printing of the Sweepstakes, administration of the Sweepstakes or in the announcement of the prizes. Sponsor reserves the right to modify the Sweepstakes rules, terms and conditions without materially affecting the terms and conditions of the Sweepstakes.

(E) Except where prohibited, participants agree that: (1) any and all disputes, claims, and causes of action arising out of or connected with the Sweepstakes, or any prize awarded, or the determination of the recipients/winners shall be resolved individually, without resort to any form of class action, and exclusively under the laws of the State of South Carolina, USA and through the courts of Greenville County, South Carolina, USA; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes but in no event attorneys' fees; and (3) under no circumstances will participants be permitted to obtain awards for and participants hereby waive all rights to claim punitive damages, incidental damages, consequential damages or any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. (NOTE: Some jurisdictions do not allow the limitation or exclusion of liability for incidental or consequential damages, so the above may not apply to you.) All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participant or Sponsor in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of South Carolina, USA without giving effect to any choice of law or conflict of law provisions.

(F) If for any reason the Sweepstakes is not capable of running as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the Sweepstakes entry process, and to cancel, terminate, modify or suspend the Sweepstakes. In the event of the cancellation, termination, or suspension of the Sweepstakes, Sponsor may award Sweepstakes prizes in a random drawing from all eligible entries received up to the date of termination, cancellation or suspension.

(G) Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, registrations or entries. Sponsor is not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any email, order or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to a participant's or any other person's computer relating to or resulting from participation in the Sweepstakes or downloading any materials in the Sweepstakes.

(H) **WARNING: ANY ATTEMPT BY A PARTICIPANT OR ANY OTHER PERSON TO DELIBERATELY DAMAGE THE WEBSITE (OR ANY SPONSOR WEBSITE) OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING SEEKING CRIMINAL PROSECUTION.**
