SCANSOURCE GIVE US YOUR INSIGHT SWEEPSTAKES OFFICIAL RULES

The ScanSource Give us your Insight Sweepstakes (the "Sweepstakes") is sponsored by ScanSource, Inc. ("ScanSource" or "Sponsor") and is open only to "Insight Sales Reps," who are defined as individuals who are: (1) full time employees of Insight Enterprises, Inc. ("Insight") with the title of Sales Representatives (2) 21 years of age or older; and (3) legal residents of the 50 United States and the District of Columbia. Direct Marketers ("DMARs"), "e-tailers," other Distributors, Manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Sweepstakes.

1. SWEEPSTAKES PERIOD; VALID SUPPLIER.

Sponsor's clock is the official time-keeping device for this Sweepstakes.
- (B) <u>Valid Supplier</u>. For purposes of these Official Rules, "<u>Valid Supplier</u>" is defined as Datalogic.
- **2. HOW TO ENTER.** Insight Sales Reps may enter and receive Sweepstakes entries the following ways:

(A) <u>Deal Registration Entries</u>.

- (1) <u>Deal Registrations</u>. For purposes of these Official Rules:
- (a) a "<u>Deal Registration</u>" is defined as a <u>potential</u> sale of Valid Supplier products (purchased from ScanSource and sold to a third party) that has been registered by an Insight Sales Rep through the submission of a completed Deal Registration Form (at <u>www.</u>) during the Sweepstakes Period;

- (2) <u>Deal Registration Entries</u>. Each service quote request and each Deal Registration must be original and unique; no duplicates or copies of service quote requests or Deal Registrations will be accepted. Direct Marketers ("<u>DMARs</u>"), "e-tailers," Distributors, Manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Sweepstakes.
