3. How to Make Claims and Collect Points


Claiming Datalogic products sold to your customers is simple, easy and quick. Simply fill out the form on the page.

It takes less than a minute, so get started!

- > Log in with your credentials on www.datalogic-loyaltyleague.com
- > Go to the CLAIM tab.



- > Fill out the form. Please consider:
 - Invoice Number You need to mention the number of the invoice sent to your customer
 - Invoice Date that the invoice was issued
 - Customer Name Fill in the name of the customer to whom your company is selling
- > Select the product category


- > You can claim Datalogic products sold up to 3 months after the invoice date.
- > Please add the PE number if you have one
- > You have 48 h to edit your claim. After this time, it will be processed by the system.
- > Claims can be audited by Datalogic; you'll get a notification email with a request to upload your invoice to the specified link when this is the case.

4. How to Redeem Points

When you login, you can always check your point status on the top right-hand side of the page.



> By clicking on your number of points, the system will show you all the gifts available for the points collected.



- > You can select on a gift and click on ORDER to redeem your points.
- > The system will ask you to confirm your order and provide data according to EU regulations.

DREAMZONE

Our dream zone is an area in which you can select the dream gift you're aiming to save for. Each time you log in, you'll see it on the left side of the website. It updates automatically, letting you know how many points remain to reaching your goal.

To activate this feature, go to the catalog and click on the gift you would like to receive to open the gift specifications page. Then, click on the "Add to Favorites" button to save your selection in the dream zone.

5. Frequently Asked Questions

1. I would like to order a product that is not included in the catalog. Is this possible?

You can choose from the products that are listed in the catalog. The catalog is updated with new products every few months, but items that are not in catalog cannot be ordered

2. How long will it take for my order to be delivered?

We do our absolute best to deliver your order within four weeks. If this is not possible for some reason, we will inform you by email.

3. Can I still change and/or cancel my order after it has been placed?

Once an order is placed, it can no longer be changed or cancelled.

4. How are the debit cards transported and delivered?

Debit cards are delivered to the registered address by a courier. If there is no one at home at the time of delivery, you will find a note in your mailbox from the courier with information on the following steps to take in order to receive your package.

5. I ordered a debit card over 5 weeks ago and still have not received it. Is there a problem? We always take great care in carrying out our orders. However, if you have not received your order within four weeks, please send an email.

6. What changes now apply to the debit cards, due to the new EU regulations?

Everyone ordering a debit card must now provide identification to receive it. Please refer to the NEWS section of the website for more information.

7. I have a question about the debit card. Whom may I contact?

8. Too many/too few points have been added/deducted. Where can I report this?

Please send an email to loyaltyleague@datalogic.com with your question relating to the number of points that have been added to/deducted from your point balance. We will inquire into this and will correct your point balance if we find an issue.
