# SCANSOURCE 2019 A3 COMMUNICATONS SALES TEAM SWEEPSTAKES PROMOTION OFFICIAL RULES

The ScanSource 2019 A3 Communications Sales Team Sweepstakes Promotion (the "<u>Promotion</u>") is sponsored by ScanSource, Inc. ("<u>ScanSource</u>" or "<u>Sponsor</u>") and is open only to "<u>A3 Sales Team Members</u>" (as defined below). The Promotion consists of two (2) separate sweepstakes, (1) the "<u>Manager/Sales Rep Sweepstakes</u>," and (2) the "<u>Sales Engineer Sweepstakes</u>."

For purposes of these Official Rules, "A3 Sales Team Members" are defined as individuals who are: (1) full time employees of A3 Communications, Inc. ("A3 Communications") with the title of (a) Account Manager or Inside Sales Representative ("Manager/Sales Reps") or (b) Sales Engineer ("Sales Engineers"); (2) 21 years of age or older; and (3) legal residents of the 50 United States and the District of Columbia. ## 2. BONUS HARDWARE PRODUCTS AND STANDARD HARDWARE PRODUCTS; PROSPECTIVE SALES OPPORTUNITY REGISTRATIONS.

- (A) <u>Bonus Hardware Products and Standard Hardware Products</u>. For purposes of these Official Rules, (1) "<u>Bonus Hardware Products</u>" are hardware products sold by the ScanSource Networking and Security Unit and manufactured/supplied by Aruba/HPE, Axis, Hanwha, Panasonic and Ruckus; and (2) "<u>Standard Hardware Products</u>" are all other hardware products sold by the ScanSource Networking and Security Unit that are not Bonus Hardware Products.
- (B) Prospective Sales Opportunity Registrations. #### 4. SALES ENGINEER SWEEPSTAKES.

A Sales Engineer will receive one (1) Sales Engineer Sweepstakes entry for each Standard Hardware Products Prospective Sales Opportunity Registration submitted (and approved by ScanSource) during the Promotion Period. A Sales Engineer will receive two (2) Sales Engineer Sweepstakes entries for each Bonus Hardware Products Prospective Sales Opportunity Registration submitted (and approved by ScanSource) during the Promotion Period.
- (B) <u>Sales Engineer Sweepstakes Drawing</u>; <u>Odds</u>. Sponsor will select one (1) Sales Engineer Sweepstakes Prize winner in a random drawing on or about January 3, 2020 in Greenville, South Carolina (USA). Odds of winning depend on the number of eligible Sales Engineer Sweepstakes entries received.

#### 5. GENERAL ELIGIBILITY AND ENTRY MATTERS.

- (A) <u>Eligibility</u>. The Promotion is open only to "<u>A3 Sales Team Members</u>." For purposes of these Official Rules, "<u>A3 Sales Team Members</u>" are defined as individuals who are: (1) full time employees of A3 Communications with the title of (a) Account Manager or Inside Sales Representative ("<u>Manager/Sales Reps</u>") or (b) Sales Engineer ("<u>Sales Engineers</u>"); (2) 21 years of age or older; and (3) legal residents of the 50 United States and the District of Columbia. Direct Marketers ("<u>DMARs</u>"), "etailers," Distributors, Manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Promotion. Officers, directors, and employees of Sponsor and its parents, subsidiaries, and other affiliated companies, agents, and advertising and promotional agencies, and their immediate family members (defined as parents, spouse, children, siblings, grandparents) and those with whom they are domiciled, are NOT eligible to enter or win.

#### 6. WINNER NOTIFICATION AND AFFIDAVIT: GENERAL PRIZE RESTRICTONS.
